AMENDMENT.

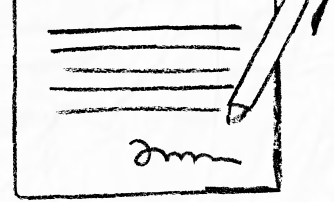
In the said Rules, in rule 5, in sub-rule (1), for the words "one year", the words "eighteen months" shall be substituted.

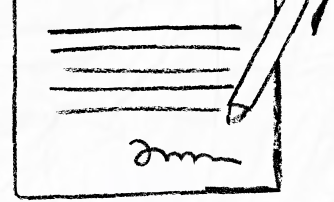
