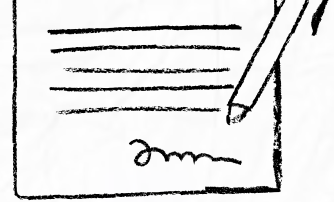
AMENDMENT.

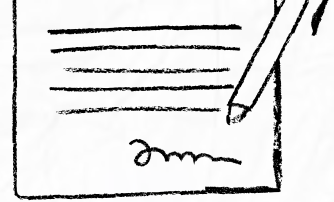
