During the review of Area Plans Unit by the Member-Secretary, CMDA on 21.09.2012, it was observed that applicants take a very long time for furnishing Archaeological Survey of India clearance after submission of Planning Permission Application, which in turn result in accumulation of pendency of PPAs in CMDA. Therefore it was decided that PPA requiring Archaeological Survey of India clearance need not be admitted at all without prior clearance of Archaeological Survey of India.

Hence it is ordered that Planning Permission Applications requiring Archaeological Survey of India clearance will be admitted in CMDA only when the No Objection Certificate issued by Archaeological Survey of India is furnished along with the Planning Permission Application.

This order takes immediate effect.
