Sub: Establishment – CMDA - Urban Development – Chennai Metropolitan Area – Amendment to Town & Country Planning Act – Planning Permission – Validity period increased from 3 years to 5 years – Applicability of the Act provision – Office Order- Issued.

Read: 1. Notification dated 30.03.2017 in Tamil Nadu Government Gazette Extraordinary.
2. Office order No.3/2017 dated 18.04.2017
3. A.R.No.17/2017 dated 21.4.2017

In the Office Order 2nd read above, it has been directed that all concerned divisions should take the amendment made by Govt. in Section-50 of Town and Country Planning Act, 1971 by revising the validity period of the Planning Permission from 3 years to 5 years, on record and compliance.

Further, based on the Authority Resolution No.17/2017 dated 21.4.2017, the applicability of Town & Country Planning Act provision making the validity period from 3 to 5 years shall be extended for the following cases, and also has to be taken on record and compliance

- (i) All the Planning Permissions issued with the three years validity period which will be expiring on or after 30.3.2017.
- (ii) Applications received for the renewal of Planning Permission and under examination by CMDA / Local Body as on 30.3.2017.

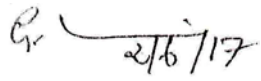
