Sub: Establishment – CMDA – Area Plans Unit – Second Master Plan for Chennai Metropolitan Area, 2026 – G.O.Ms.No.121 dated 25.9.2015 – Permitting the maximum height proportionately for the buildings consisting of Stilt + 3 Floors (or) Ground Floor + 2 Floors; Stilt + 2 Floors (or) Ground Floor + First Floor with more than 6 Dwelling Units – Orders – issued.

2. A.R.No.16/2017 dated 21.4.2017.

The Authority in its Resolution A.R.No.16/2017 dated 21.4.2017 have resolved to ratify the action of permitting the height of the Special Building consisting of Stilt + 3 floors (or) Ground Floor + 2 floors, Stilt + 2 floors (or) Ground floor + First floor with more than 6 dwelling units upto 13.5m and 10m respectively, instead of 12m and 9m (on proportionately in similar line of the height increased to 17m for Stilt + 4 Floors Special Building in G.O.MS.No.121, H&UD (UD-I) Dept. dated 25.09.2015) and also approved to continue the same.

It is therefore, directed that all concerned divisions should take this amendment on record and compliance.

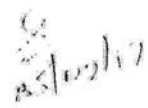
