ORDER:-

The application seeking technical clearance for the proposed formation of residential lay out sub division to an extent of 0.14 Acre or 566.00 sqm in land bearing S.F.NO 272/3A1B of Mangalam Village and Panchayat, Tiruppur South Taluk, Tiruppur District was processed as per the prevailing rules and after perusing the records and after conducting site inspection, Road pattern map was approved as per reference 2 nd cited above On receipt of payment of Open space Reservation charges, Centage charges and Development Charges vide reference 12 th cited above, the technical clearance is issued to the mentioned layout Sub division with details given below and subject to the following conditions:

Layout Sub division Area - 0.14 Acre or 566.00 sqm

Allotted Plots - 04 Nos .

The Applicant paid Rs 1,55,650/-on 22.05.2025 as Open Space Reservation Charges in lieu of allotted Park Area of 56.60 Sq.m. to be reserved as per Govt Orders mentioned in 5 th Cited above)

The Technical Clearance is issued to the above mentioned layout sub division and the number is assigned as SWP/DTCP/Tiruppur LPA/ Sub division No. 44 /2025 and Planning Permission No. 44/2025

General Conditions:

1. The local authority shall accord permission duly following the rules /regulations/Orders issued from time to time under the respective Acts.
- 2.The local authority shall accord permission/approval after collecting requisite fees/charges as applicable and the copy of the approval issued shall be forwarded to this office for record.
- 3.Also, the local authority shall forward the copy of such permission/approval to the office of the Sub registrar of Registration department and the office of the Assistant Director of Survey and land records concerned for information and for making mutation in their records.
- 4.Also, the local authority shall forward the copy of such permission/approval to the Tahsildhar concerned with a direction to the applicant to pay the requisite charges for making mutation in the Tamil Nilam/Collabland website.
5. The acknowledgement of receipt of proceedings and drawing shall be forwarded to this office through mail.

SPECIAL CONDITIONS:

1. This office has not legally certified the title to the ownership by granting the technical clearance and planning permission only the entitlement to develop the land by the applicant is verified through the documents uploaded in the web portal. Any person wishing to purchase the property must individually ascertain the ownership of the property of the developer/seller. If any dispute arises towards the ownership, the same shall be settled through the appropriate forum. This office is not the appropriate authority to decide on this.
2. The owners / developers shall be allowed either to carry out Infrastructure development works as per the standards specified by the local body concerned or to pay the estimate cost to the local body. Concerned local body shall prescribe the standards for the provisions of basic infrastructure like roads, drains, water supply etc. for the sub-division, as per existing rules. Before taking over the infrastructure developed by the owners / developers, the local bodies shall ensure the quality of the works done by the owners/ developers. Reasonable period to be prescribed for up keep/maintenance of the roads and drains by the owners/developers. Wherever sub-division develop at a slow pace, the maintenance period shall be extended till 60% of the plots developed in the sub-division or 5 years whichever is later as envisaged under the directions issued by the Government Order vide references 8th, 9th and 10th cited above.
3. As envisaged under the "Tamil Nadu Real Estate (Regulation & Development) Act 2016, the promoter has to advertise, market, book, sell or offer for sale or invite persons to purchase in any manner any plot, apartment or building, as the case may be, in any Real Estate Project or part of it only after registering the Real Estate Project with the Real Estate Authority. The applicant has to comply the said provisions.

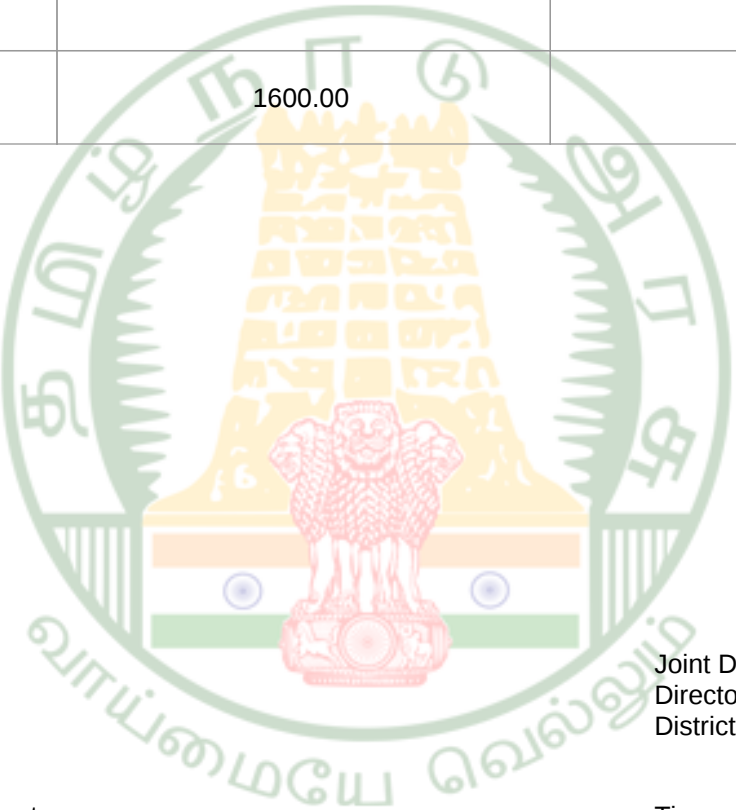
