Body of the letter:

The application seeking technical approval for the proposed construction of Industrial Building Cottage industries type -Ornaments and jewellery (including bangles, combs) of Krishnagiri District, Hosur Taluk/ Corporation, Hosur Town of Approved SIDCO layout No.10/2017, Plot No.112, ward : A, Block No 21, T.S.No 49, S.F.No 576pt, Site Extent- 486.70 sq.m, Builtup area 346.51 sq.m sq.m (Ground Floor + First Floor+ Guard room) was processed as per the prevailing rules and after perusing the records and after conducting site inspection. The Proposed Building satisfies the rules and power delegation given by Director of Town and Country Planning vide reference letter 8th cited above.

1)With the above area, the proposed industrial building proposal is given technical approval with the following special and general conditions. The building plan planning permission Numbered as BP/H.N.T.D.A.(K.D) No.08/2023. The planning permission period from 01.02.2023 to 31.01.2031 (8 Years)

2) The local authority shall accord permission duly following the rules / regulations/ Orders issued from time to time under the respective acts.

3) The Local authority shall accord Final approval after collecting requisite fees / charges as applicable and the copy of the approval issued shall be forwarded to this office for record.

4) The acknowledgement of receipt of proceedings and drawing shall be forwarded to this office through mail.

Special conditions:

1) This office has not legally certified the title to the ownership by granting the technical clearance and planning permission. Only the entitlement to develop the land by the applicant is verified through the documents uploaded in the web portal. Any person wishing to purchase the property must individually ascertain the ownership of the property of the developer / seller. If any dispute arises towards the ownership, the same shall be settled through the appropriate forum. This office is not the appropriate authority to decide on this.

2) It is responsibility of the builders in ensure safe bearing capacity of the soil and adequacy of the foundations.

3) Pollution Control Board NOC to be obtained.
