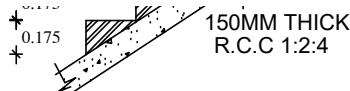

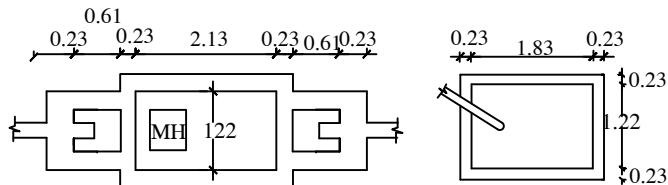

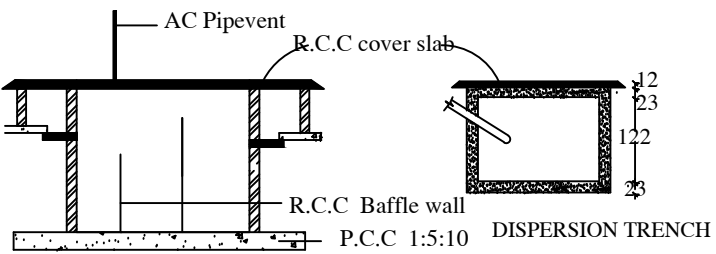
SITE PLAN



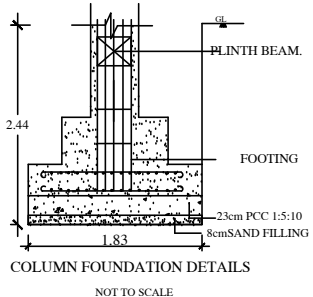
STAIRCASE DETAILS

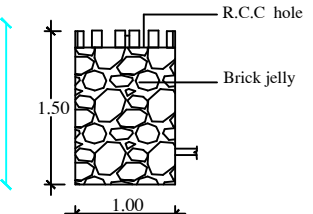

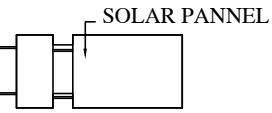
