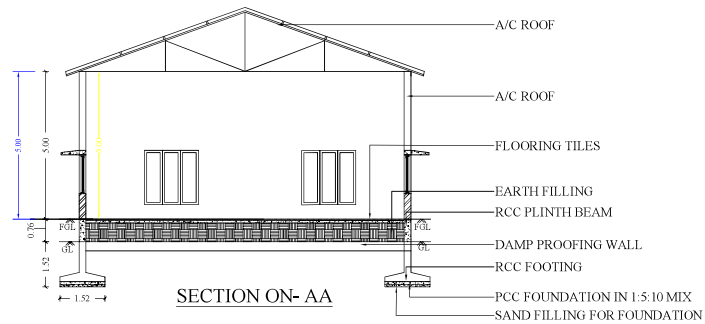
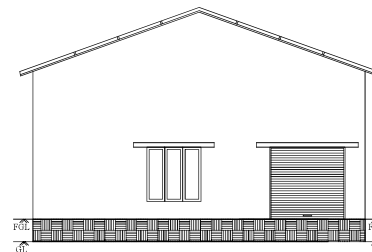

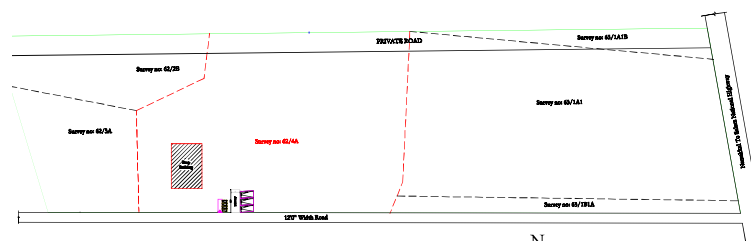

SITE PLAN (Survey no: 62/4A)

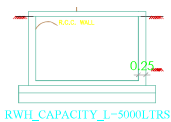


SITE PLAN
NOT TO SCALE

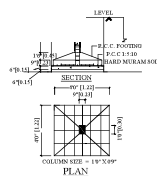

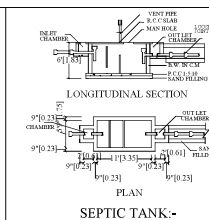

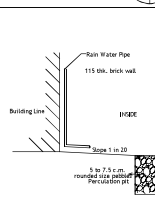

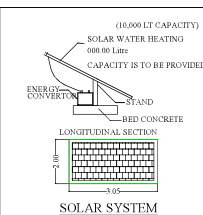

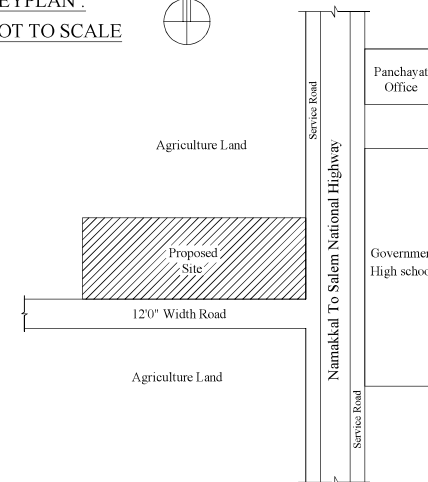


PERCOLATION PIT :
