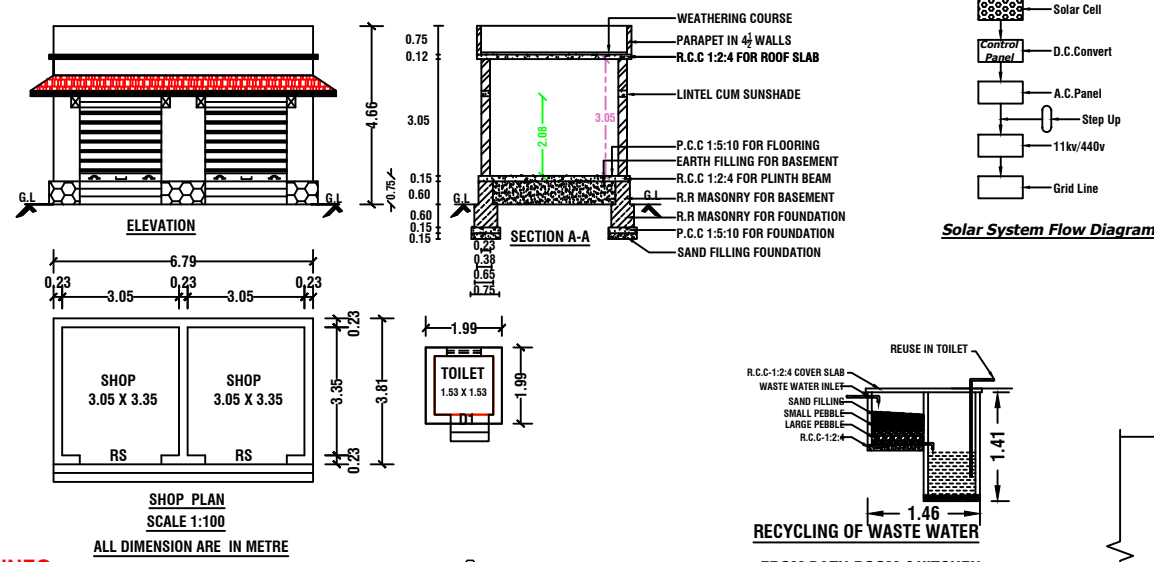


PLAN SHOWING THE PROPOSED CONSTRUCTION OF SHOP BUILDING IN R.S.NO : 561/7A1B OF
