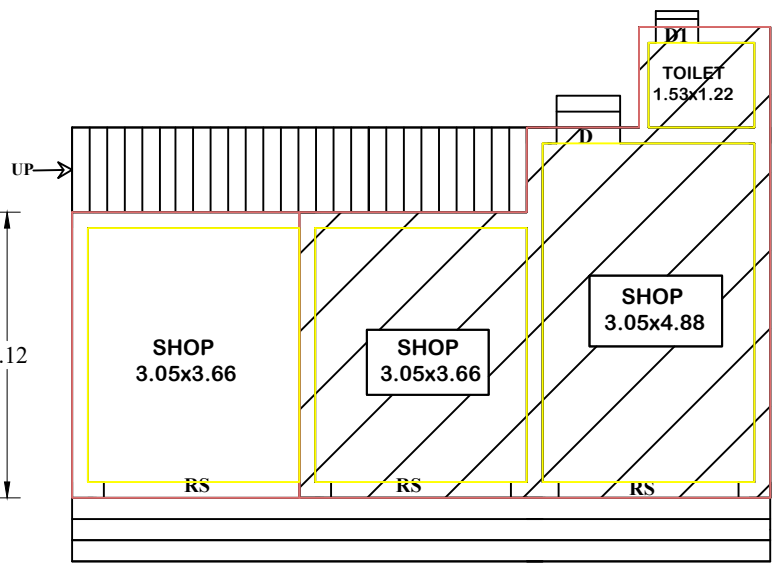

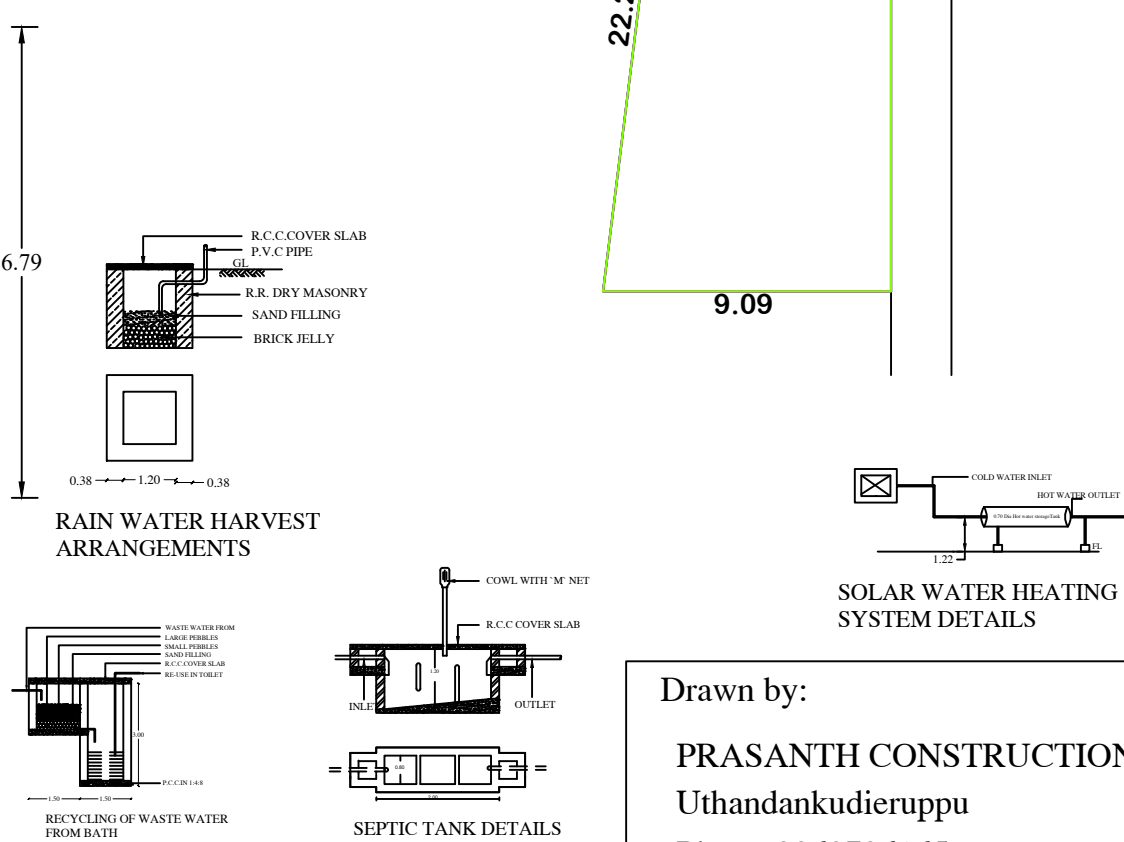
FIRST FLOOR PLAN



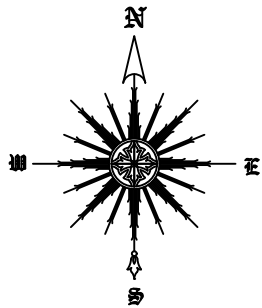
2ND FLOOR PLAN
