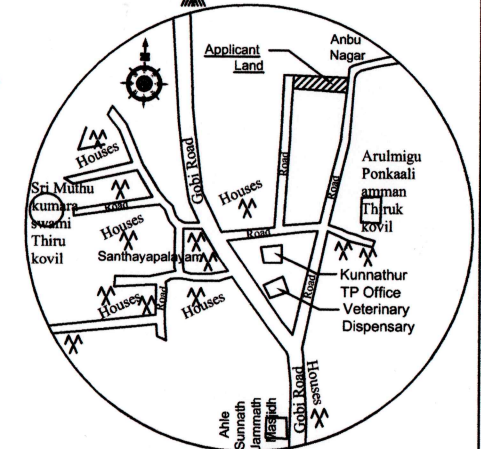

FRONT ELEVATION NORTH FACING



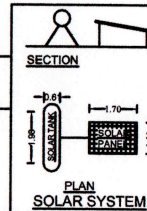

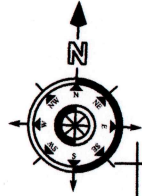
