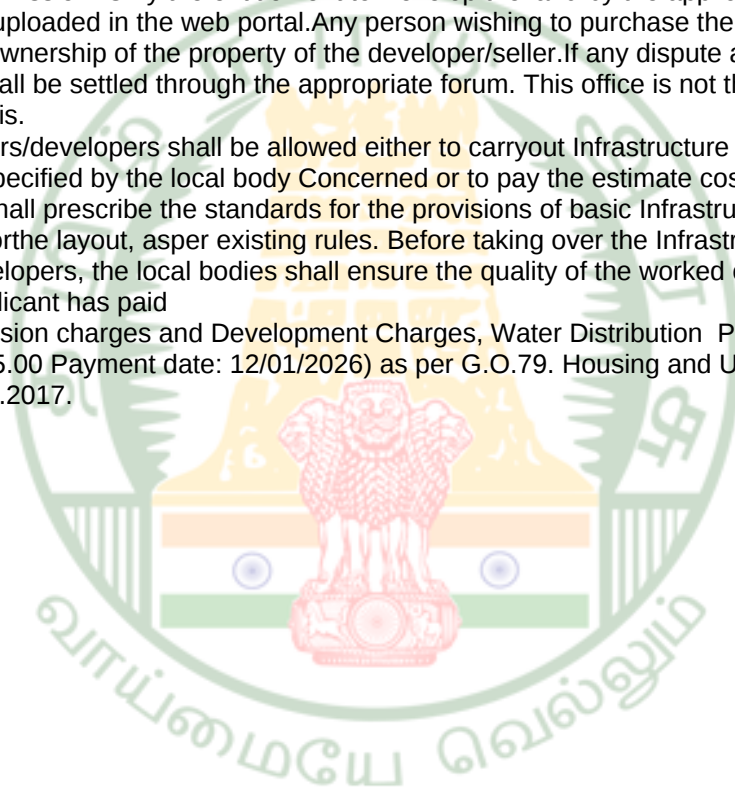

The application seeking technical clearance/ concurrence/Planning Permission for the proposed formation of Residential layout Application (Reference No. Z6KT1VVX/2025/TCP) to an extent of Acre 2.30 in the land bearing S.No.80/1A. Valukkalotti Panchayat / Village, Kariapatti Taluk / Panchayat union, union Final order issued.

SPECIAL CONDITIONS:

1. This office has not legally certified the title to the ownership by granting the technical clearance and planning permission. Only the entitlement to Develop the land by the applicant is verified through the documents uploaded in the web portal. Any person wishing to purchase the property must Individually ascertain the ownership of the property of the developer/seller. If any dispute arises towards the ownership, the same shall be settled through the appropriate forum. This office is not the appropriate authority to decide on this.
2. The owners/developers shall be allowed either to carry out Infrastructure development works as per the standards specified by the local body Concerned or to pay the estimate cost to the local body. Concerned local body shall prescribe the standards for the provisions of basic Infrastructure like roads, drains, water supply etc. for the layout, as per existing rules. Before taking over the Infrastructure developed by the owners/developers, the local bodies shall ensure the quality of the worked one by the owners/developers. And the applicant has paid Land conversion charges and Development Charges, Water Distribution Pipe Line Charges (Rs.6,41,535.00 Payment date: 12/01/2026) as per G.O.79. Housing and Urban Development Department, Dated:04.05.2017.
