2. That the said land is free from all encumbrances.

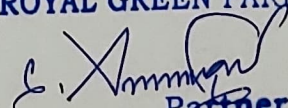
3. That the time period within which the project shall be completed by me/promoter is **FULLY DEVELOPED AND COMPLETED**.
