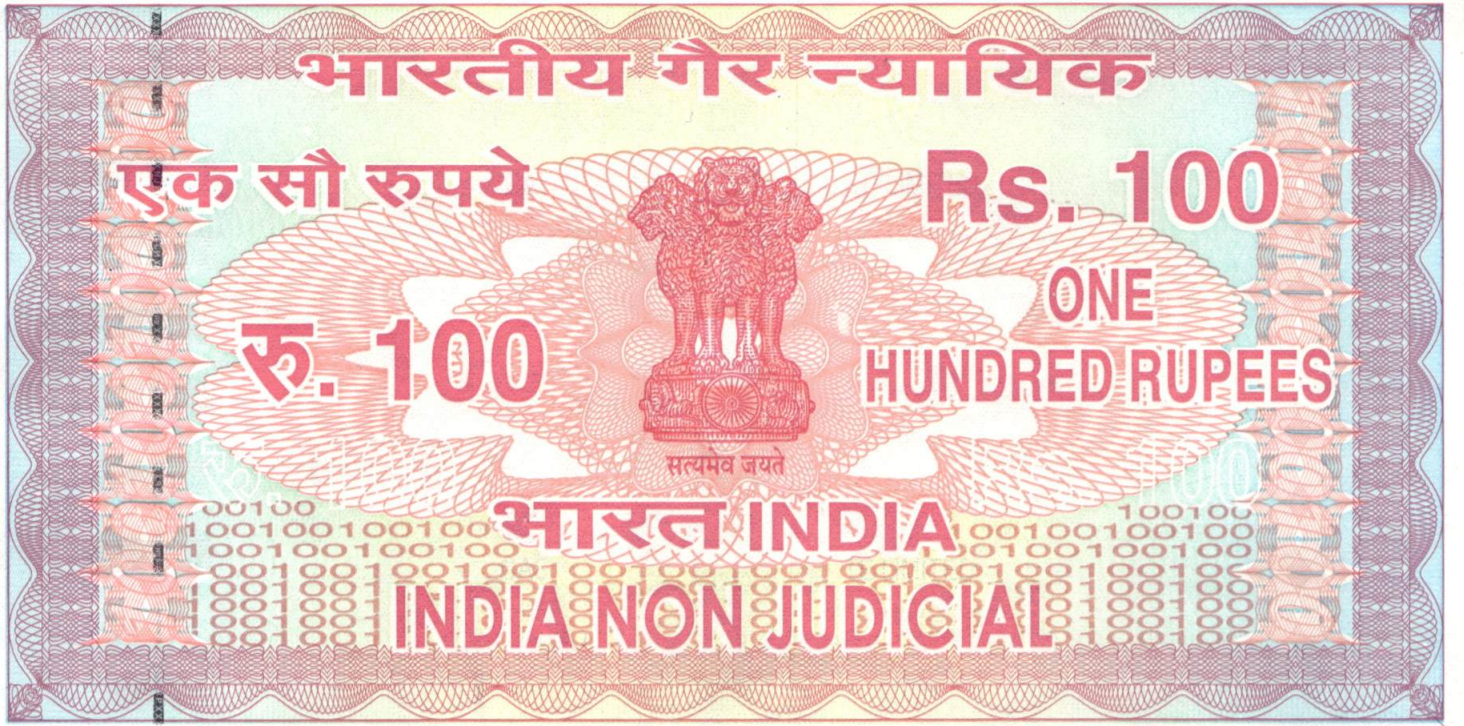

1. That the Scheduled Property has been purchased through valid registered sale deed(s) and the title of the schedule property is clear, marketable and free from encumbrances. Subsequent to the above we have obtained patta in our favour.

That the Water Resources Department (WRD) has issued directions regarding the (i) construction of a RCC culvert have been proposed at essential location in Channal SF.No.409/1 of Pazhanthandalam Village to access from our project site in SF. No. 404/2 North to SF. No. 409/2 of Pazhanthandalam Village, the said construction of the culvert has been undertaken by us. (ii) constructing the retaining wall on both side of the Govt. channel along entire boundary as per the FMB at our own cost, which is running in S.F. No.457, 460 461, 462 & 463 and SF. No.409/1, 410/1 & 411/1 on western and South- Western side both abutting on our project land (iii) to avoid inundation and to supply water

from chembarambakkam Reservoir to the ayacut at downstream side of the applicant's land and to drain out the rainwater properly during the monsoon seasons, a minimum clear width of 3.00m to be maintained and ensured.

3. That the said culvert has been constructed under our supervision and responsibility, and the work is being/has been carried out in accordance with the requirements stipulated by the Water Resources Department without causing any hindrance to free flow of water in government channels.
4. That we hereby confirm that all remaining requirements, conditions, and instructions, if any, as requested by the Water Resources Department, vide letter Number DB/T5(3/F-10194NOC-Pazhanthandalam Village 0784/2026, dated 06.02.2026 shall be duly complied with and completed by us within the prescribed time of project completion.
5. That this Deed of Indemnity is executed solely for the purpose of submission before the Tamil Nadu Real Estate Regulatory Authority (TNRERA) in connection with the registration of the real estate project "CASAGRANDE HIGHCITY PHASE - I" under the provisions of the Real Estate (Regulation and Development) Act, 2016.
