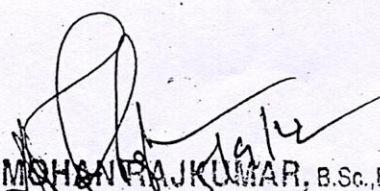

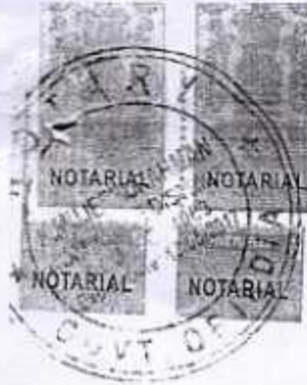

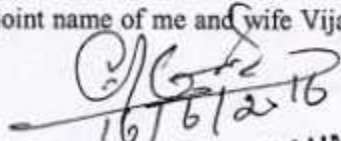

I hereby bequeath that after my death the properties as stated above which are exclusively belonged to me and my absolute undivided right in the properties which are in the joint name of me and Vijayarani and in joint possession with building, improvement, jenmam right and joint enjoyment with Vijayarani shall be in the enjoyment of my wife Vijayarani till her death and my undivided right in the Flat no 9A described above where in me and wife Vijayarani are residing shall exclusive devolve upon my wife Vijayarani with absolute right of disposition and disposal.
