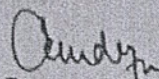

POLICIES/GUIDELINES FOR ISSUE OF NOC

Dear Sir,

1. Reference is made to your application for issuance of NOC for construction of multi storied commercial building consisting of Block A, B and C, located at CTH Road, Korattur, Chennai-600050 and in Survey No.s 44/2, 44/3, 45/1 and 46/2, Block No. 81, Ward-E, Kakapallam Village, Ambattur Taluk, Thiruvallur District, Greater Chennai Corporation Zone VII, Division 60, Tamil Nadu dated 02 Jun 2020.
2. New policies and guidelines have been issued by Government (Gazette notification GSR 751E dated 30 Sep 15) to ensure time bound clearances for projects/infrastructure under the drive for 'Ease of doing Business'. Colour coded Zoning Maps have been formulated to assist decision making by Local Municipal Authority (LMA) based on the distance of the proposed infrastructure from IAF airfield.
3. For all building and obstructions which falls within "RED ZONE" of Air Force Station Tambaram, NOC is to be obtained. NOC is also required from Tambaram, if the building height is more than 69M (AMSL) in "SKY BLUE" or "PINK ZONE", 144M (AMSL) in "YELLOW ZONE" and 174M (AMSL) in "GREEN ZONE". Comprehensive NOC procedures along with relevant forms are available on IAF web site www.indianairforce.nic.in>Services>ATS>NOC.
4. Since building is planned within "GREEN ZONE" (22373M from 23 dumbell) of Tambaram and maximum height of the building is 58.45M (43.60M+14.85M) AMSL and 05.00M (Height of crane above the proposed building during construction), NOC from IAF is not required. **The proposal may be submitted to LMA** and after issuance of NOC letter by LMA, a copy of letter may please be forwarded to Chief Operational Officer, Air Force Station, Tambaram, Chennai-46 within 30 days of approval for cross checking the clearances, monitoring the construction of building, updating of Obstruction Data and Navigation charts.
5. This is for your information and necessary action, please.

Your site is located at a distance 11912 mts from ARP and lies in the grid E13 of the published CCZM of Chennai airport. The Permitted top elevation for this grid is 95 mts.

Since the requested top elevation 40.5 mts in AMSL is below CCZM permitted top elevation, the NOC for height clearance is not required from Airports Authority of India.

3. This assessment is subject to the terms and conditions as given below:

a. The site-elevation and site coordinates provided by the applicant are taken for calculation of the permissible top elevation for the proposed structure. If however, at any stage it is established that the actual data is different from the one provided by the applicant, this assessment will become invalid.

b. The Site coordinates as provided by the applicant in the NOC application has been plotted on the street view map and satellite map as shown in ANNEXURE. Applicant/Owner to ensure that the plotted coordinates corresponds to his/her site. In case of any discrepancy, this assessment shall be treated as null and void

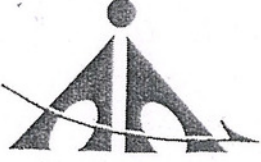
c. Airport operator or his designated representative may visit the site (with prior coordination with applicant or owner) to ensure that assessment terms & conditions are complied with.

d. The assessment is further subject to the provisions of Section 9-A of the Indian Aircraft Act, 1934 and any notifications issued there under from time to time including the Aircraft (Demolition of Obstruction caused by Buildings and Trees etc.) Rules, 1994.

e. The applicant is responsible to obtain all other statutory clearances from the concerned authorities including the approval of building plans. This assessment for height is to ensure the safe and regular aircraft operations and shall not be used as document for any other purpose/claim whatsoever, including ownership of land etc.

f. Use of oil, electric or any other fuel which does not create smoke hazard for flight operations is obligatory, within 8 KM of the Aerodrome Reference Point.

g. This assessment has been issued w.r.t. the Civil Airports as notified in GSR 751(E). Applicant needs to seek separate NOC for Defence, if the site lies within jurisdiction of Defence Airport. Applicants also need to seek clearance from state Govt. as applicable, for sites which lies in the jurisdiction of unlicensed civil aerodrome as outlined in Rule 13 of GSR751 (E).

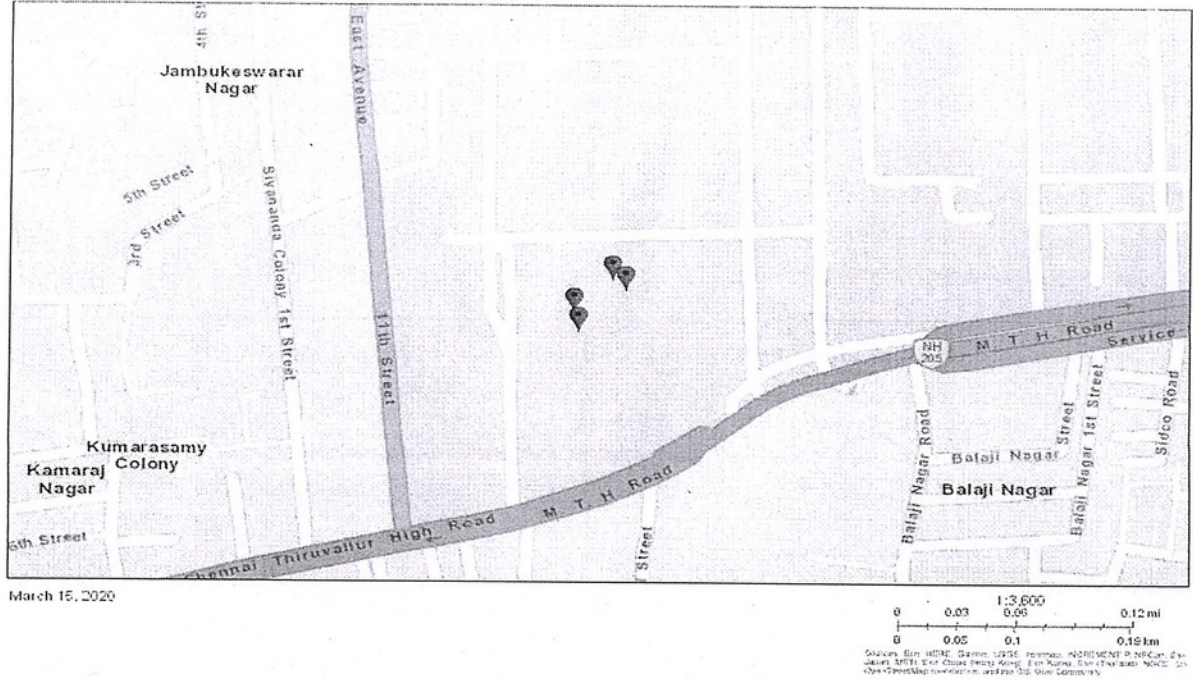
