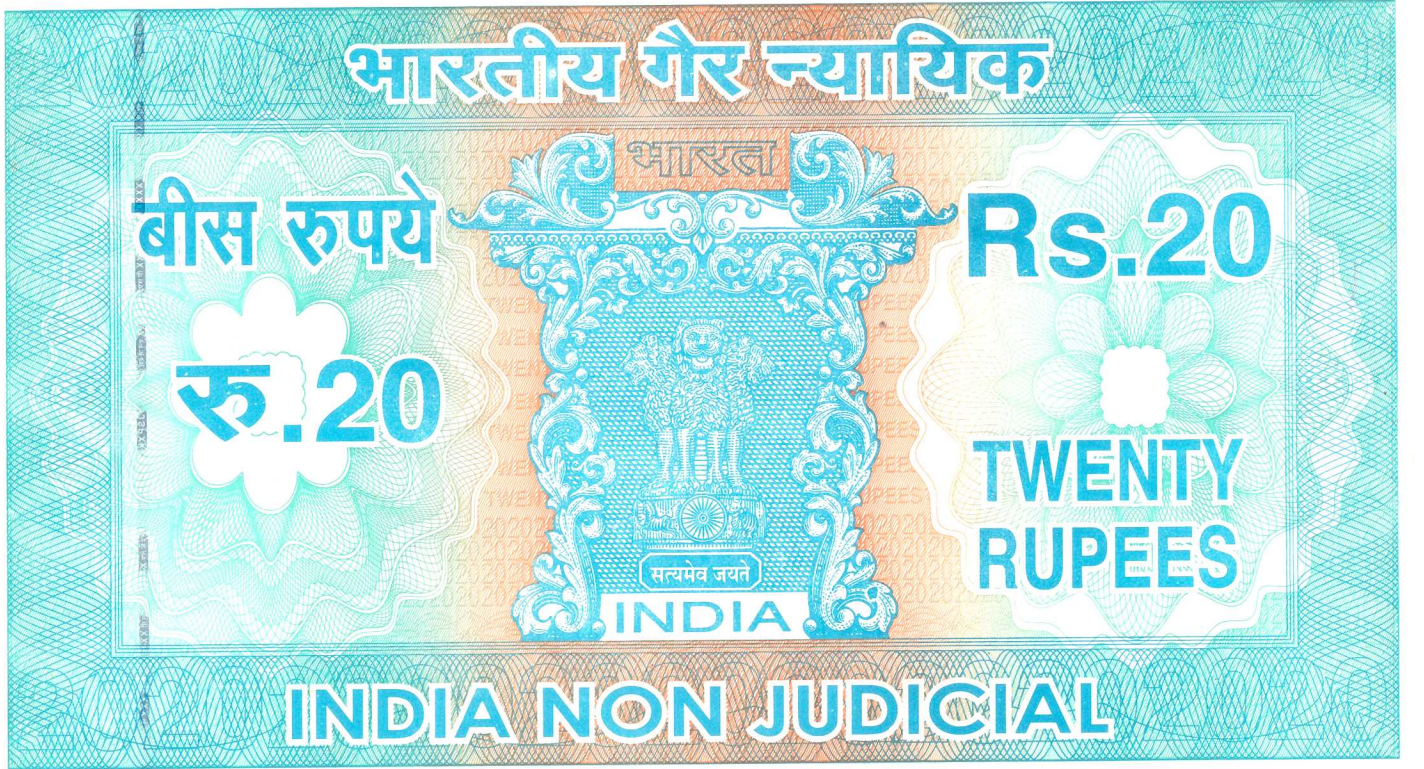

For layout projects, it will be cost of development and the land cost.
5. For layout projects, the withdrawal can be done after obtaining a certificate from the Architect / Licensed Surveyor stating that the project has been developed and completed in all respects as per the layout approved by the competent authority.
6. That we **K.Chandran And N.Prabu** promoter shall get the accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant to the Authority and it shall be verified during the audit that the amounts collected for a particular project have been utilized for the project and the withdrawal have been made in compliance with the proportion to the percentage of completion of the project.
7. That we **K.Chandran And N.Prabu** shall take all the pending approvals on time, from the competent authorities.
8. That we **K.Chandran And N.Prabu** have / has furnished such other documents as have been prescribed by the rules and regulations made under the Act.
9. That we **K.Chandran And N.Prabu** shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be, on any grounds.

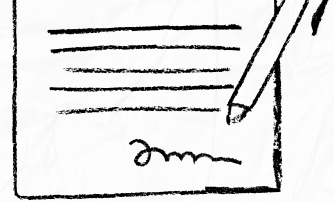

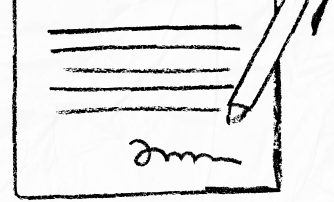
