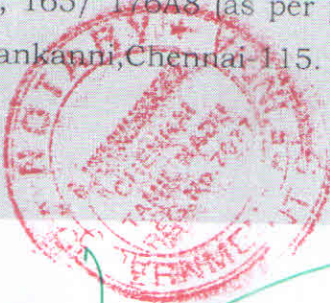

ORDER:-

Tr. Sanjay Jayapal, at No. 78/132, Dr. Radhakrishnaan Salai, Mylapore, Chennai-04, wherein he has requested for No Objection Certificate in 'Form B' towards location clearance for the proposed construction of Ground floor (Part)/ stilt (Part) + 2 floors Air Conditioned Cinema Theatre with 9 screens at survey No. 165/176A1, 165/176A2, 165/176A3, 165/176A4, 165/176A5, 165/176A6, 165/176A7, 165/ 176A8 (as per patta) of Injambakkam Village, East Coast Road, Vettuvankanni, Chennai-115.



2) The following authorities were addressed as per Tamil Nadu Cinemas (Regulation) Rules, 1957 in this regard vide this office letter in even No. dated 25.02.2020.

- i) The Commissioner, Greater Chennai Corporation, Chennai-03.
- ii) The District Collector, Chennai, Chennai-01.
- iii) The Joint Commissioner of Police, South Zone, GCP.
- iv) The Additional Commissioner of Police, Traffic, GCP.

3) The following reports have been received from the concerned.

- i) Notification in Form "A2" published in Chennai District Gazette No.4 (Page No.12) 132A of Tamil Nadu Gazette dated 03.10.2020 vide reference third cited received from Government Press.
- ii) The applicant has sent a compliance report along with a copy of exhibition of a Notice in the proposed site in the reference fourth cited.
- iii) The Additional Commissioner of Police, L&O (South) and the Joint Commissioner of Police, South Zone have recommended for the issue of "No Objection Certificate" in this regard.
- iv) The Additional Commissioner of Police, Traffic has also given No Objection for issue of "No Objection Certificate" on traffic point of view.
- v) The Additional Chief Secretary/ Commissioner, Greater Chennai Corporation, Ripon Building, Chennai-03 has published the A2 notice at the Greater Chennai Corporation board in the reference fifth cited.

4) The applicant has paid fee of Rs.9,000/- (for 9 screens each screen Rs.1000/-) was remitted vide Challan No.0557038, dated :16.08.2019.

5) The request of the applicant for issue of No Objection Certificate for the proposed construction of Ground floor (Part)/ stilt (Part) + 2 floors Air



Conditioned Cinema Theatre with 9 screens at survey No. 165/176A1, 165/176A2, 165/176A3, 165/176A4, 165/176A5, 165/176A6, 165/176A7, 165/ 176A8 (as patta) of Injambakkam Village, East Coast Road, Vettuvankanni, Chennai-115 is considered and "No Objection Certificate" in form 'B' for the construction of Air Conditioned Cinema Theatre as stated above under rule 36 in Part II and u/r 106 Part - VII of Tamil Nadu Cinemas (Regulation) Rules 1957 is issued. This No Objection Certificate is valid for a period of 5 years from date of issue as per rule 36(3) of Tamil Nadu Cinemas (Regulation) Rules 1957. If within this period, the proposed cinema is not put up, a fresh no objection certificate should be applied.

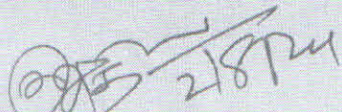

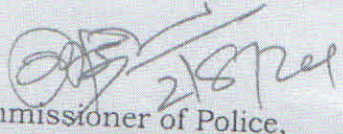
