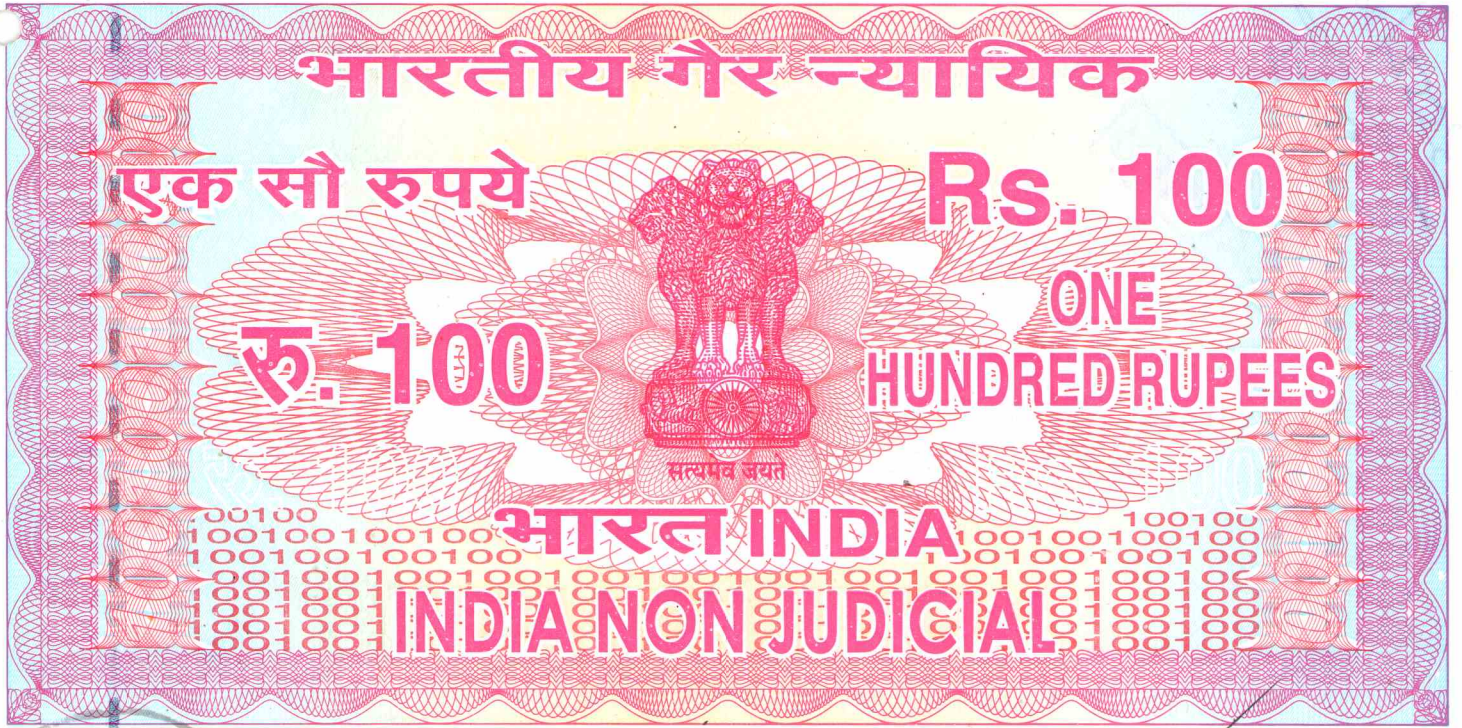

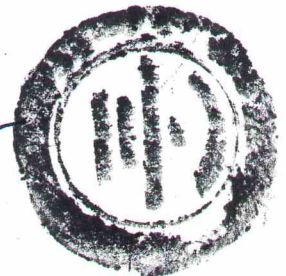

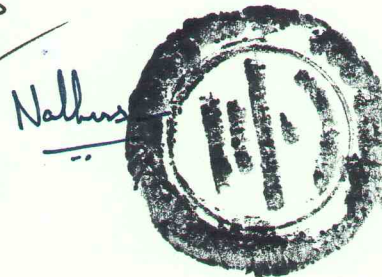

WHEREAS:

- A. The Principal and Attorney are the joint owners of the property being Plot No. B180, measuring an extent of 7056 Square Feet together with the super structure having super built up area measuring an extent of 16877 square feet comprised in FIVE floors situated at Plot No. B-180, Door No.5, 54th Street, 9th Avenue, Ashok Nagar, Chennai-600083 (previously The Sanction Plan of Ashok Nagar Scheme Kodambakkam Village), comprised in T.S. No. 60, Block No.70, situated at Kodambakkam Part 2 Town (Previously Kodambakkam Village), Mambalam Taluk, Chennai District, which is more fully described in the Schedule "A" hereunder and herein after referred to as "**Schedule A Property**".
- B. Originally, the Schedule A Property was purchased by the father of the Principal and Attorney, namely, Mr. M.K. Hussain from Tamil Nadu Housing Board vide a Sale deed dated 12.09.1990, Document No.5055/1990 at SRO Kodambakkam. The said Mr. M.K. Hussain @ M. Khursheed Hussain died on 02.02.1991 leaving behind his wife Mrs. Atiya Khursheed Hussain and sons Mr. Mahin Hussain and Nahin Hussain as his legal heirs and the same is evidenced vide legal heirship certificate bearing ref no. D.DIS.07/03718/91 issued by Tahsildar of Mambalam-Guindy Taluk on 04.03.1991.
- C. Further, the said Mrs. Atiya Khursheed Hussain died on 14.02.2016 leaving behind her sons Mr. Mahin Hussain and Nahin Hussain and the same is evidenced vide legal heirship certificate bearing ref no. R.Dis. (D1)/4647/2017 issued by Tahsildar of Mambalam Taluk on 18.07.2017.

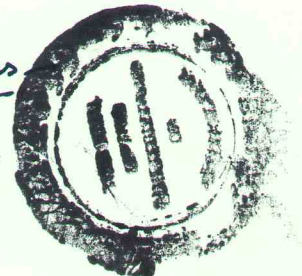
- D. Thereafter, the Principal and Attorney herein equally had inherited the Schedule A Property. Further, the patta got mutated in the names of principal and Attorney issued by Zonal Deputy Tahsildar Mambalam.
- E. Thus, the Principal and Attorney herein have got the equal rights, title and ownership over Schedule A Property and each owns half share over the Schedule A property.
- F. The Principal are not able to attend to various matters relating to the aforesaid property and have executed this Power of Attorney empowering the Agent to deal with his Half Share over the Schedule "A" mentioned property, which is morefully described in Schedule "B" hereunder and herein after referred to as said property.

NOW THEREFORE THIS DEED OF POWER OF ATTORNEY WITNESSES AS FOLLOWS:

The PRINCIPAL above named and as described in the preamble do hereby irrevocably appoint, constitute, nominate, retain and ordain his brother Mr. Mahin Hussain, as my true and lawful Power of Attorney (POWER AGENT) and as described in the preamble to do the following actions on my behalf with respect to the Schedule mentioned Property:-

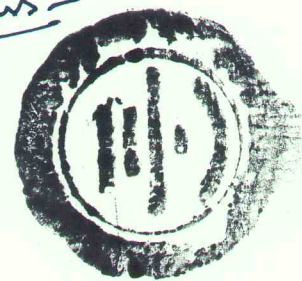

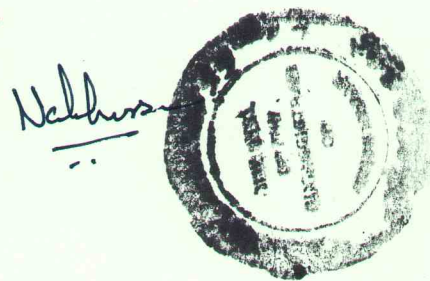
7. To correspond with and receive any correspondence or other intimation from the CMDA/ DTCP, Corporation of Chennai, Tamil Nadu Housing Board or any other competent authorities regarding the plans, sanctions, approvals or permits for construction of any building/s on the Schedule "A" mentioned property for the provision of any amenities or facilities thereto.

8. To get demolition plan approval, reconstruction plan sanction, building permit and planning permit, service connections such as water, sewerage, electricity, etc and also to demolish the old building and to develop the properties apart from empowering the Attorney and to deal with the properties in such manner as may be required for development of the same.

9. The Power of Attorney is fully authorised to represent the Principal to process the approval of the development and other necessary approvals from RERA authority as required under the provisions of RERA Act and Rules.

10. The Power of Attorney is authorised to sign and execute all forms, declarations, affidavits, representations and submit all details, data and information as required for the said process, on our behalf. The Power of Attorney is authorised and empowered to process the RERA approvals for the projects and comply with all the necessary provisions of RERA Act and rules on behalf of the Principal. 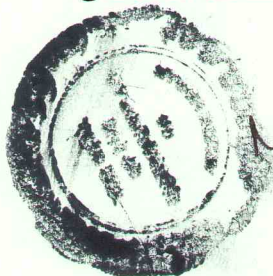

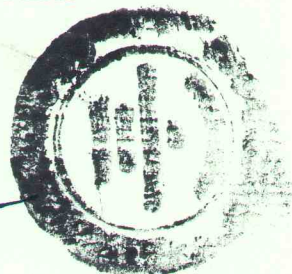

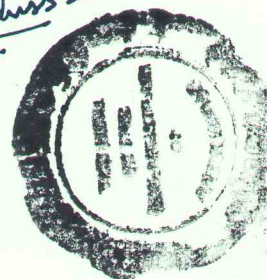

30. To execute Gift Deeds and hand over possession of OSR or other land to authorities concerned for the purposes of obtaining sanctions.

31. To pay such fees, taxes, charges, levies and other dues in respect of anything done or to be done pursuant to these presents

32. Generally to act as the Attorney or Agent of Principal in relation to the matters aforesaid and in all other matters in which the Principal may be interested or concerned and on behalf of the Principal to execute and do all deeds, acts or things as fully and effectively in all respects as if the Principal would have done the same personally.

This Power of Attorney shall be valid and in force till the same is revoked in writing only by way of the Principal executing and registering the deed of cancellation along with the Power of Attorney. The Principal shall not unilaterally cancel this Power of Attorney. Further the powers shall not be cancelled by the Principal till the Power of Attorney fully acts upon the powers and entirely realises the scope of powers as granted for the development of the Schedule "B" property.

No consideration is passed on under this Power of Attorney.

And the Principal hereby agree to ratify and confirm all and whatsoever acts their Attorney shall lawfully do or cause to be done by virtue of the powers granted under this Deed.
