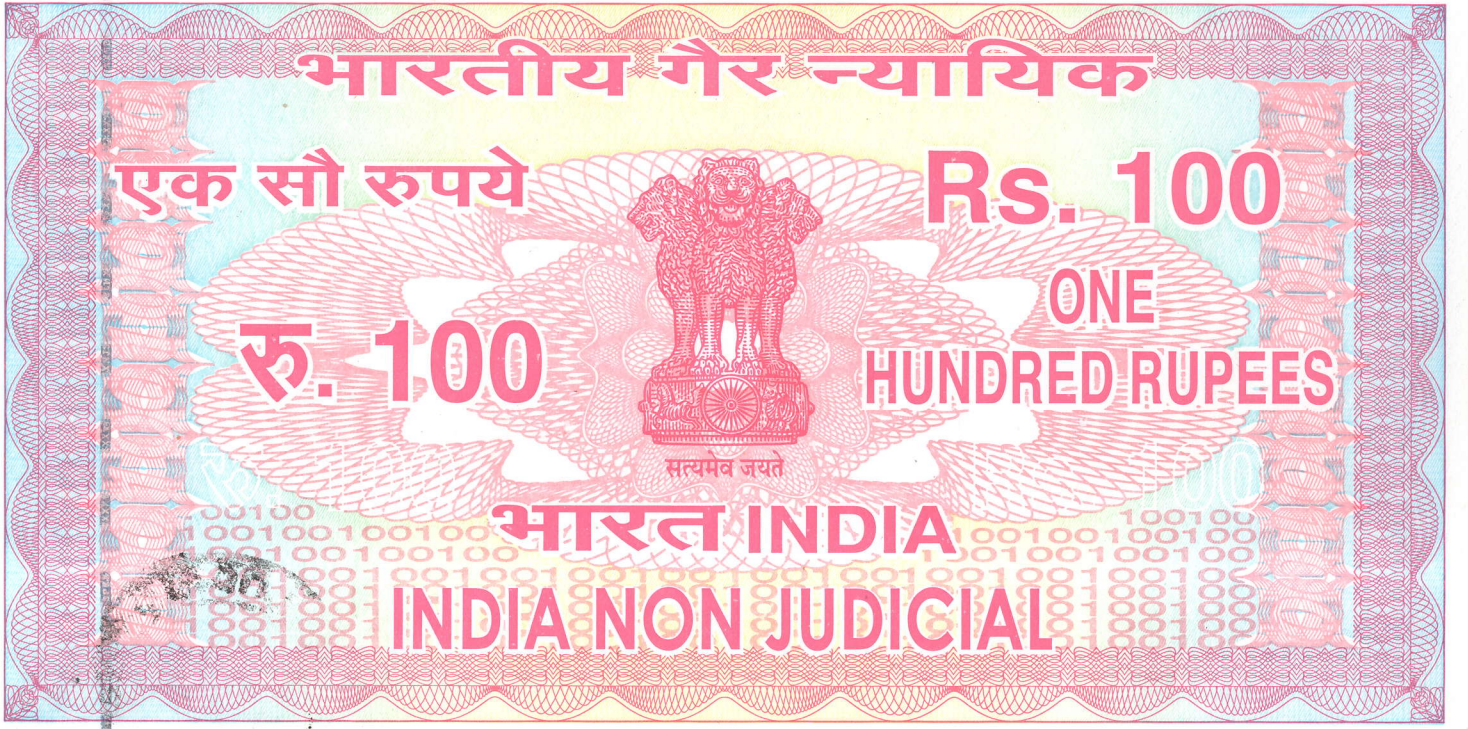

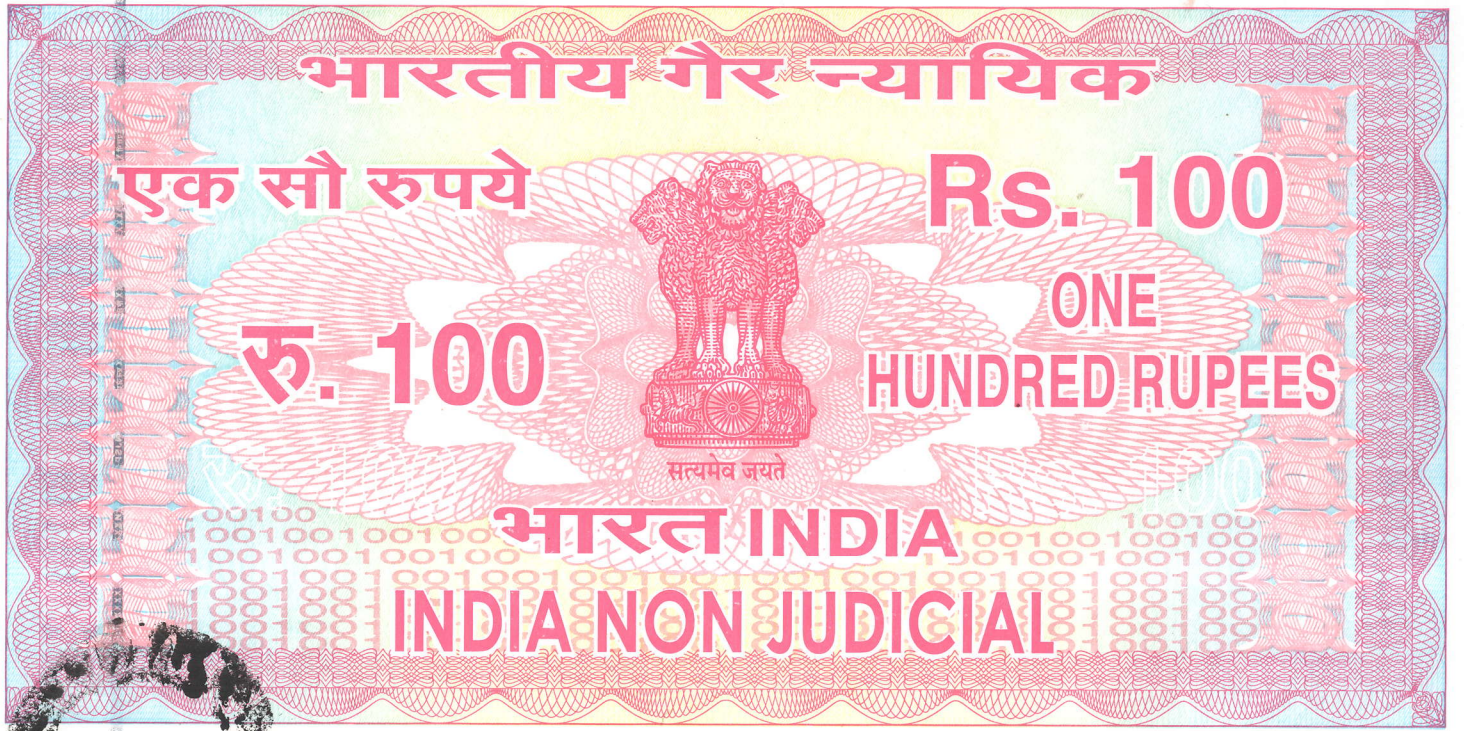

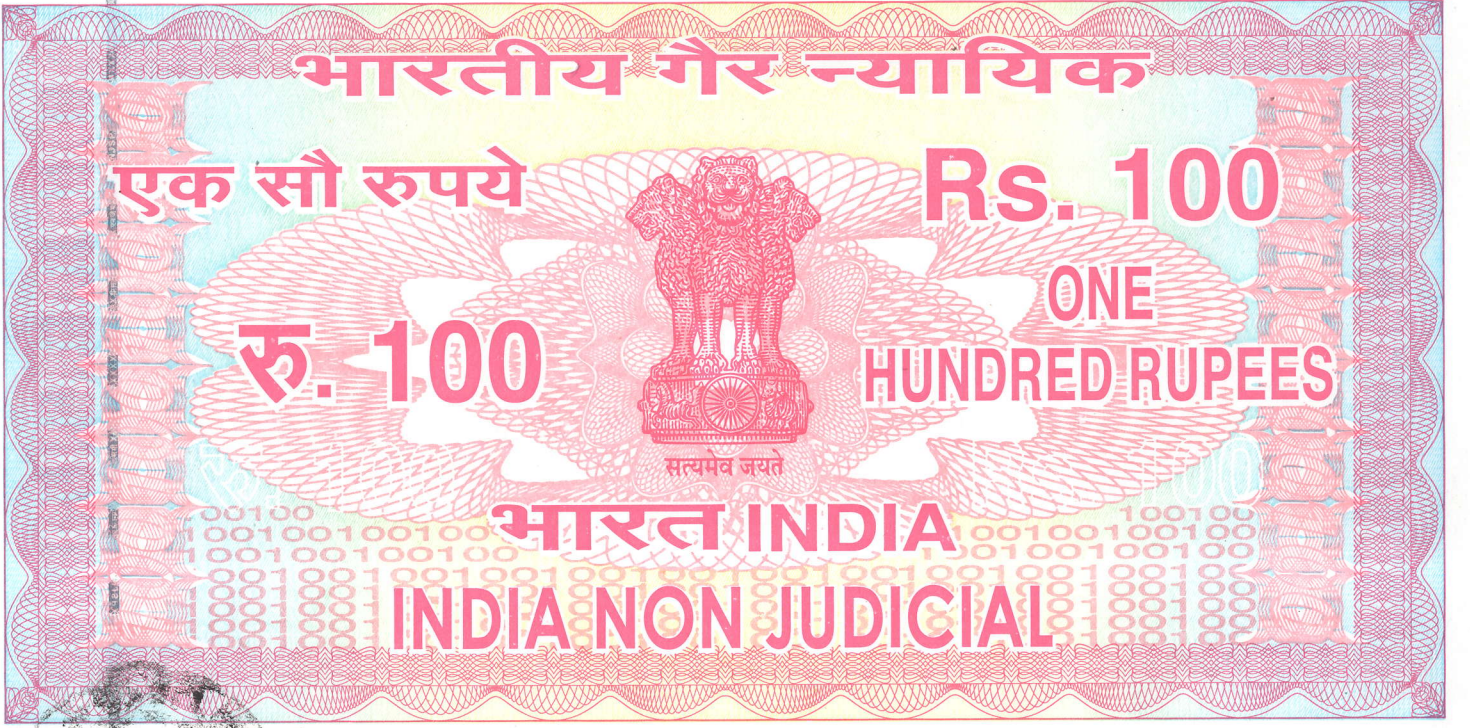

NOW THIS DEED OF PARTNERSHIP WITNESSETH AS UNDER:

1. The terms of this deed shall take effect from 4th April 2024.
2. The name of the firm shall continue to be **"EK INFRA"**.
3. The registered office of the firm shall continue to be located at Flat No.101, RS Elegance, Phase-1, Ravi Main Road, Medavakkam, Chennai - 600 100. The firm may also open branches at such other places as the partners may decide.
4. The partnership firm shall mainly carry on the business of construction of all kinds of Infrastructure Projects, Steel Fabrication, Road Works, Building Construction, Interior Works, Repairs & Maintenance, Earth Moving contracts & Road Marking, Contract in all Government and Private Sectors and also consulting, Promoting & Developing of Lands, Plots, villas, Individuals Houses, Apartments, Shopping malls & Townships. And to undertake Real Estate Activities in connection with buying and selling of land(s), building(s) and lay-out(s), construction of buildings and other Civil works and to carry on manufacturing or production or trading of all construction materials, house hold materials and interior work materials also to carry on the business of Transportation and rendering of logistic services. The firm may also carry on such other business as the partner herein may mutually agree.



5. All the Three partners shall be working partners and shall entitle to remuneration as per the limits fixed by the Income Tax Act 1961 from time to time.
6. The revised capital contribution of partners shall be as mutually agreed to by them.
