Land Survey department at Perambalur District.

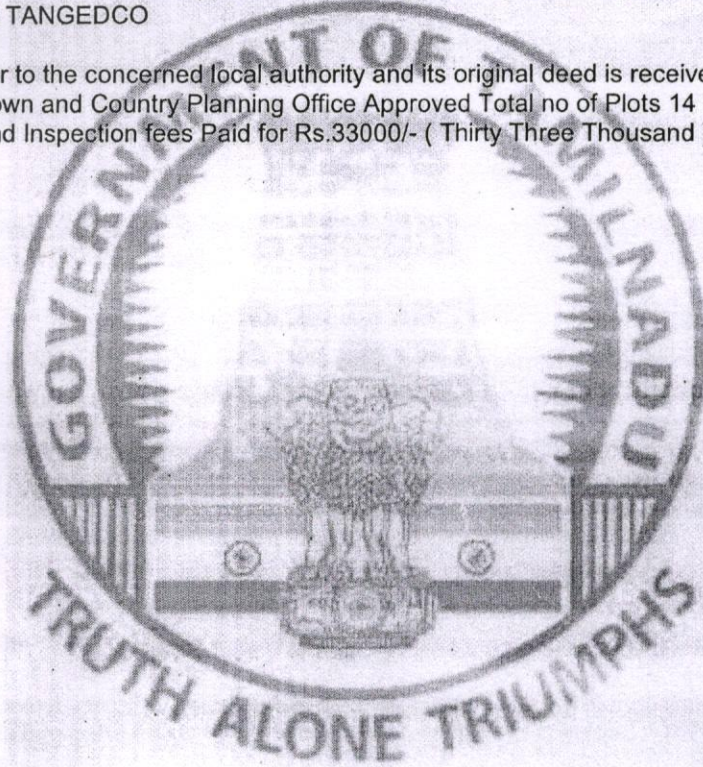
3. It is requested to send the acknowledgment of receipt after obtaining the online approved layout and proceeding orders.
