11. Any Difference in the Rates Paid By the Petitioner Shall Be Paid By the Petitioner As Soon As The Fee

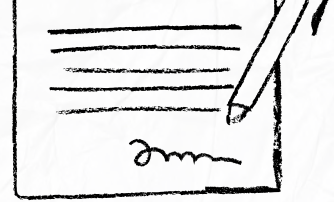

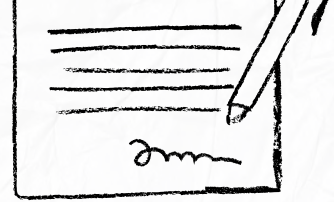
