Conditions:-

1. The permission is given on the basis of the conditions mentioned in the subdivision map permission of the Director of Town and country planing, Chennai and the Joint Director of Town and country planing Department, Coimbatore, District Urban Development Office, Coimbatore District.
2. The map shall not be used for any purpose other than that for which it was authorized.
3. It is the responsibility of the owner to pay the specified amount within 7 days of receiving the notification in case if it is found less charges are paid and also even if it is known that any charges are to be paid other than the sanctioned charges for issue of Plot license.
4. Before construction of buildings on the land in the subdivision, permission should be obtained from the municipality for each building. After the completion of the construction work, the house tax has to be paid.
5. The permission of other departments of the Central State Government is allowed to be obtained in any case for setting up a Plot .
6. If any or all of the above conditions are violated or the Plot is laid out in deviation from the approved plan, the owner shall be liable to action and liability as per rules.
7. After the approval of the Plot map, at the place where the Plot is approved, the resolution number, date and the Plot map shall be published for public view at the entrance of the Plot without any change through a permanent information board of size 6"X 4".
8. EWS Plots should not be combined or converted into Plot s allotted to the economically backward.
9. Map approval is subject to the provisions of the Tamil Nadu Panchayats Act, 1994 and the Tamil Nadu Rural and Town Planning Act.
10. In addition to the above conditions, the map is approved subject to such conditions as may be imposed by the Government or the Panchayat Council from time to time.
11. Amount for change of land use Rs 49000 /- (Rupees. Fourty nine thousand only) i.e :- 3% of market value Paid through Challan No. 20260514006053 Dated : 14.05.2026 in appropriate Govt head.
12. Rs. 120480/- (Rupees. One lakh Twenty Thousand Four Hundred and eighty only) as consideration fee and development fee for Panchayat online Receipt No. :- 2026051563311 Date :- 15.05.2026 has been paid into SNA account of Panchayat through website.
