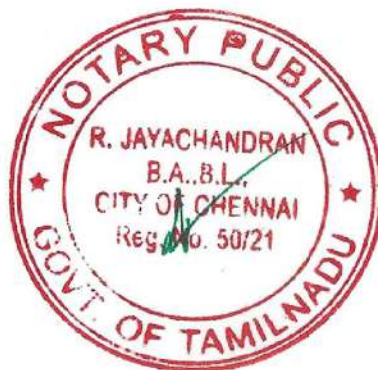

constituted vide a Power of Attorney dated 14.07.2025, registered as Document No.2143 of 2025, in the office of the Sub-Registrar Ashok Nagar, hereinafter referred to as the **INDEMNIFIER**;

WHEREAS the INDEMNIFIER is the promoter/developer of the Real Estate Project known as “**KCEE KALPAVRIKSHA**” consisting of Flat Nos.1, 2, 3, 4, 5 and 6 situated at LIG Block No.G, 55th Street, Ashok Nagar, Chennai 600083, promoted by Tamil Nadu Housing Board, more fully described in the Schedule hereunder, under a scheme of Joint Development.

AND WHEREAS the Schedule mentioned property is owned by 1.(i) Chitra Kailash, 1.(ii). K.Rajagopalan, 1.(iii). Padma Krishnamurthy, (2) Varalakshmi Mekalai, 3.(i) Maragathavalli, 3.(ii) S.Srividhya, (4) N.S.Venkataraman and (5) M.S.Srikanth (Owners).

AND WHEREAS the Tamil Nadu Real Estate Regulatory Authority has noted a difference in the area between the extent of the project as recorded in the Sale Deeds, Tamil Nadu Housing Board Letters and the Patta uploaded in respect to the project.

AND WHEREAS the Sale Deeds executed by the Tamil Nadu Housing Board in favour of its allottees recorded only the Flat Nos. and the Flat area and did not record the corresponding undivided share for each Flat.

AND WHEREAS the Tamil Nadu Housing Board had issued Letters dated 13.03.2023 and 22.06.2023 stating that the undivided share for each Flat in LIG Block No.G is 1002 Sq.ft.

AND WHEREAS the Extract the Permanent Land Register (PLR) records an extent of 550 sq.mts. (equivalent to 5920 Sq.ft.) in the names of the INDEMNIFIER and each of the Flat Owners were entitled to 986.67 Sq.ft. undivided share in said total extent of 5920 Sq.ft.

AND WHEREAS the above variation in undivided share extent has arisen due to the discrepancy between the extent reflected in the Tamil Nadu Housing Board Letters and the extent recorded in the Patta / Permanent Land Register extract.

AND WHEREAS, in pursuance of the aforesaid Joint Development, the INDEMNIFIER agreed to develop the land described in the Schedule hereunder by constructing a new residential building with a total built-up area of 17,000 Sq.ft., and to allot to the Owners a built-up area of 10,200 Sq.ft. with 3552 Sq.ft. undivided share of land (Owners' Share), comprising Flat Nos. A, B, I, and D, E; and the INDEMNIFIER was allotted a built-up area of 6,800 Sq.ft. with 2368 Sq.ft. undivided share of land (Developer's Share), comprising Flat Nos. C, F, G, and H.
