SUB : Issuing of NOC in favour of M/s.Vinayagga Promoters for proposed construction of Stilt Floor+5 floors residential building at Plot no.6, Old Door No.4, New Door No.9, Sivasankaran Street, Rajaji Nagar, Pallavaram, Chennai, comprised in S.No. 352/2 and T.S.No.42, Block No.6, Ward-B of Zamin Pallavaram village, within the limits of Tambaram Municipal Corporation, Chengalpattu District, at Railway KM between 23/400 - 23/500 on LH side at Pallavaram Railway station in MS-VM section - Reg

With reference to CE(G)'s letter cited under Ref. 2, and upon submission of the Indemnity Bond, Deed of Unconditional Undertaking, and execution of the agreement with Railways, No Objection Certificate (NOC) is hereby issued to M/s.Vinayagga Promoters, represented by its partner A.Subramanian, for the construction of Stilt Floor+5 floors residential building at Plot no.6, Old Door No.4, New Door No.9, Sivasankaran Street, Rajaji Nagar, Pallavaram, Chennai, comprised in S.No. 352/2 and T.S.No.42, Block No.6, Ward-B of Zamin Pallavaram village, within the limits of Tambaram Municipal Corporation, Chengalpattu District, as per Division's Drawing No. **DM/PV/NOC/1**, duly approved by the Divisional Railway Manager, Chennai Division and Chief Engineer/General, Southern Railway, Chennai – 600003, subject to the following terms and conditions as stipulated in the letter cited under Ref. 2.

The NOC is issued subject to the conditions stipulated in the agreement executed between Railways and M/s.Vinayagga Promoters for the proposed construction at the site.

Terms and Conditions:

1. The party to submit an indemnity bond (i.e.Rs.100/- stamp paper) to the effect that if at a later date, it is known that if any land or part of land is identified as Railway land, then that portion or full land will be taken over by Railways without any prior notice.
2. It is to be ensured that the construction is carried out as per the structural drawings certified by Anna University so as to ensure safety of track.
3. Necessary precautionary arrangements to be made while construction of building.

4. In case any refuse is dumped by the party into the Railway land, they will have to pay necessary charges for cleaning the same and an additional fine of Rs.10000/- each time a notice is issued to them.
5. Any tree planted along the Railway boundary is liable to be cut fully or partially for safe working of Railways in terms of Para 14 of Railway Act 1989, without any compensation.
6. Railway reserve the right to supervise/Inspect during the construction stage as well as during lifetime of the building to ensure that building/basements do not cause any danger to safety of the trains
7. No tree with height more than 10 meters shall be planted/grown between the nearest Railway boundary and the nearest face of the building from such Railway Boundary.
8. The proposed NOC request for construction of residential building (Still+5 floors) only is approved.
