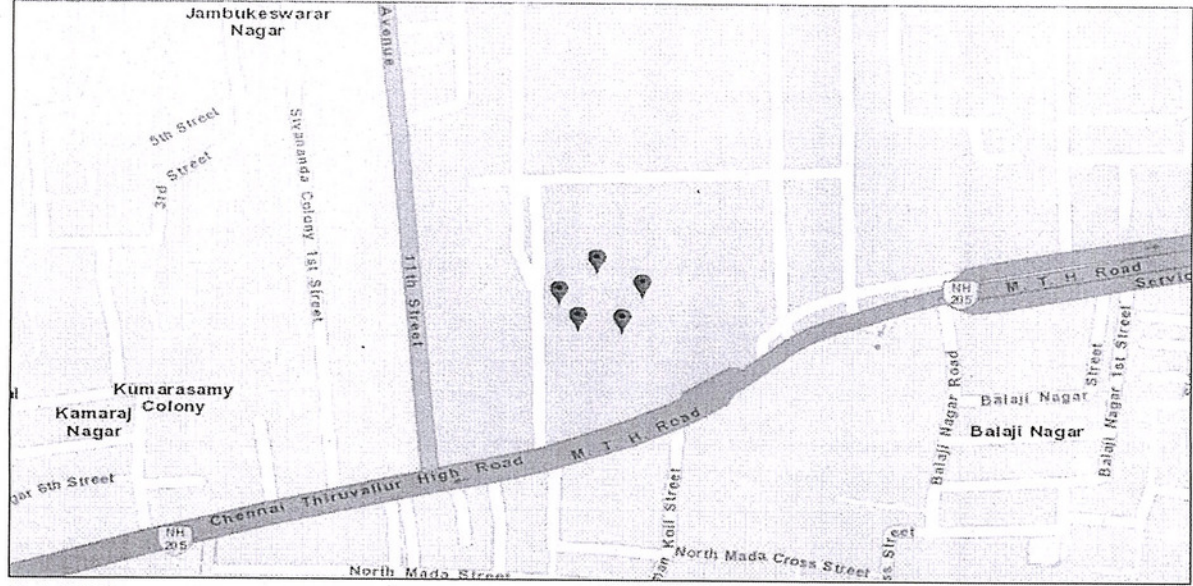

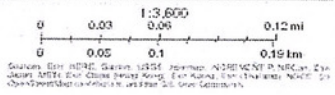

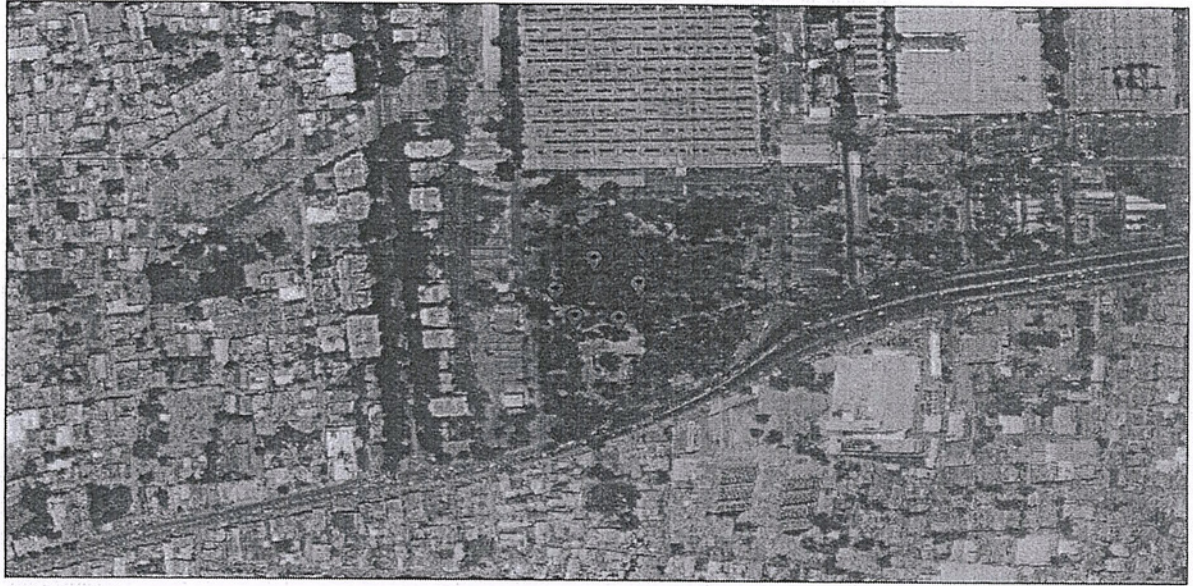
Street View



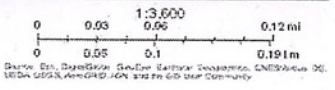
