Mrs.R.BEENA, Mrs.J.REENA MARY and Mrs.V.V.SARANYA Marudhamalai Main Road, Gandhi Layout, Coimbatore District, Vide Ref No.1 cited have requested Residential Layout permission for their layout situated in Coimbatore District, Perur Taluk, Thondamuthur Town Panchayat, Thondamuthur Revenue Village S.F.Nos. 812/1, 812/2, 813/1, 817/1, 817/2, 817/3, 837/1A, 837/1B, 837/2, 838/1A, 838/1B, 838/2, 839/1A1, 839/1B, 839/1C2, 842/1, 842/2, 843, 921/1A2, 921/1B2, 921/2, 922/2, 923, 926/1, 926/2, 926/3, and 927- (10.98.16 Hectare) measuring an extent of 27.136 Acres. The said Roads, Parks and Other Public Places have been handed over by the applicant to the Executive Officer, Thondamuthur Town Panchayat vide Thondamuthur Register Office Document No.1114/2024, Dated.09.02.2024 handed over. The Director of Town and Country Planning, Chennai in his Circular No. 320/2022/ TPC3, Dated. 07.01.2022 has accorded technical approval for the Residential Layout. Technical Sanction has been accorded in LD/TCP.14/2024. The Land conversion charges has been remitted vide Member Secretary / Joint Director, District Town and Country Planning, Chennai Letter No. 2190/2023/LPA, dated.08.12.2023. The Town Panchayat Council has given consent vide its Resolution No.42/2024, Dated:11.03.2024 for Residential Layout (544 Plots) in Thondamuthur Revenue Village is 812/1, 812/2, 813/1, 817/1, 817/2, 817/3, 837/1A. , 837/1B, 837/2, 838/1A, 838/1B, 838/2, 839/1A1, 839/1B, 839/1C2, 842/1, 842/2, 843, 921/1A2, 921/1B2 , 921/2, 922/2, 923, 926/1, 926/2, 926/3, and 927 (10.98.16 hectare) with an area of 27.136 acres.
