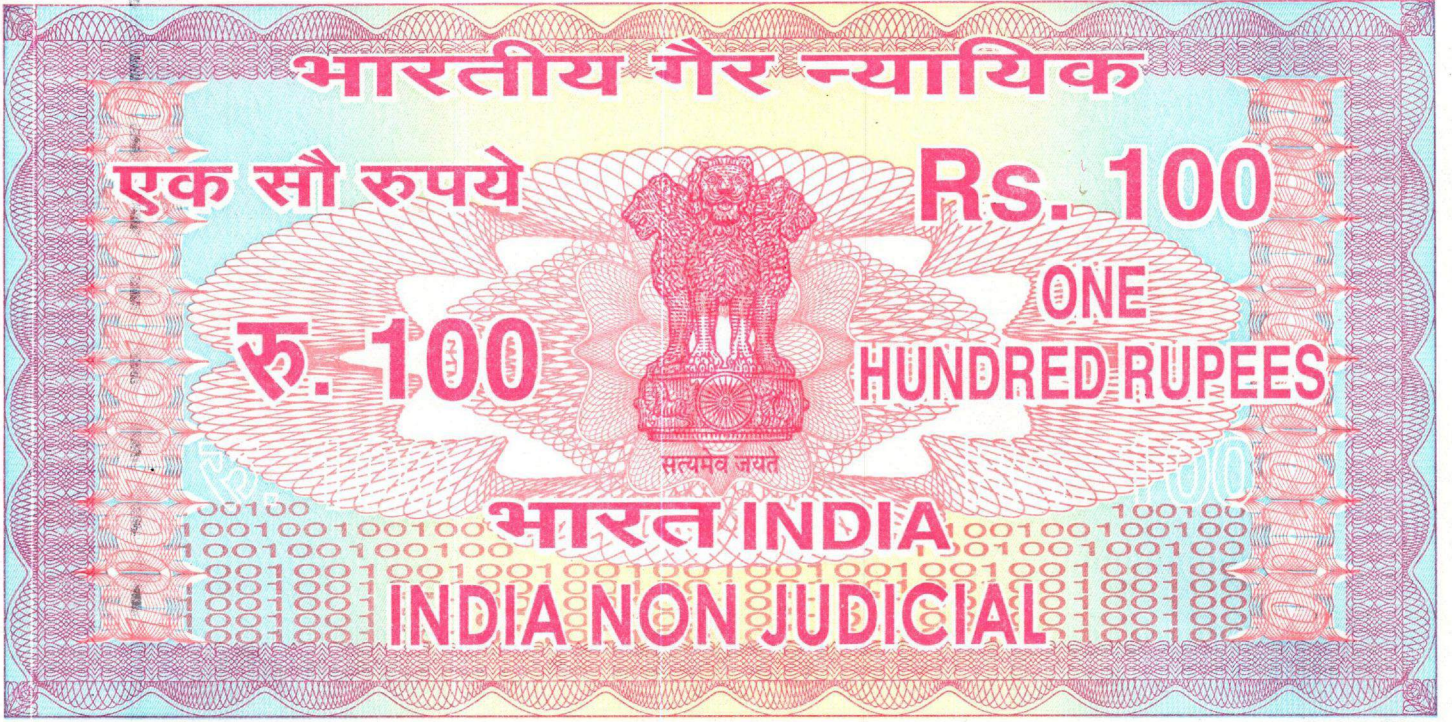

4. For layout projects, it will be cost of development and the land cost.
5.
