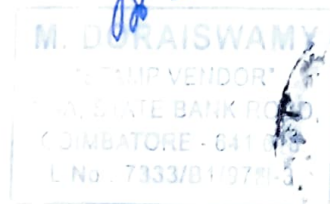

Affidavit cum Declaration of Mr. at D.Mohanraj, S/O Dharmaraj Residing at 9A, Kumaran Garden, Kuniyamuthur, Coimbatore - 641008. Promoter of the proposed Residential Project at S.F.NO-86/2B1, 86/2B2, 87/4B1 & 87/4B2 Area Extend of 2.390 Acre (or) 9675 Sq.m in Pottaiyandiporambu Village/Panchayat, Kinathukadavu Panchayat Union in Kinathukadavu Taluk, Coimbatore District, Tamilnadu

I. The requisite

I, Mr. D.Mohanraj is promoter of the proposed project do hereby solemnly declare, undertake and state as under:

1. That I promoter have has a legal title to the land on which the development of the project is proposed who possess a legal title to the land on which the development of the proposed project is to be carried out AND a legally valid authentication of title of such land along with an authenticated copy of the agreement between such owner and promoter for development of the project is enclosed herewith.

2. That the said land is free from all encumbrances.

3. That the **I completed the Site Development Work**

4. That seventy per cent of the amounts realized by me/promoter for the real estate project from the allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose, as far as building is concerned. For layout projects, it will be cost of development and the land cost.

5. That the amounts from the separate account, to cover the cost of the project, shall be withdrawn only after due certification by an engineer, architect and a chartered accountant in practice that the withdrawal is in proportion to the percentage of completion of the project, as far as building is concerned. For layout projects, the withdrawal can be done after obtaining a certificate from the Architect / Licensed Surveyor stating that the project has been developed and completed in all respects as per the layout approved by the competent authority.

6. That We/ promoter shall get the accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant to the Authority and it shall be verified during the audit that the amounts collected for a particular project have been utilized for the project and the withdrawals have been made in compliance with the proportion to the percentage of completion of the project.

7. That We/ promoter shall take all the pending approvals on time, from the competent authorities.



8. That We / promoter have / has furnished such other documents as have been prescribed by the rules and regulations made under the Act.

9. That We / promoter shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be, on any grounds.
