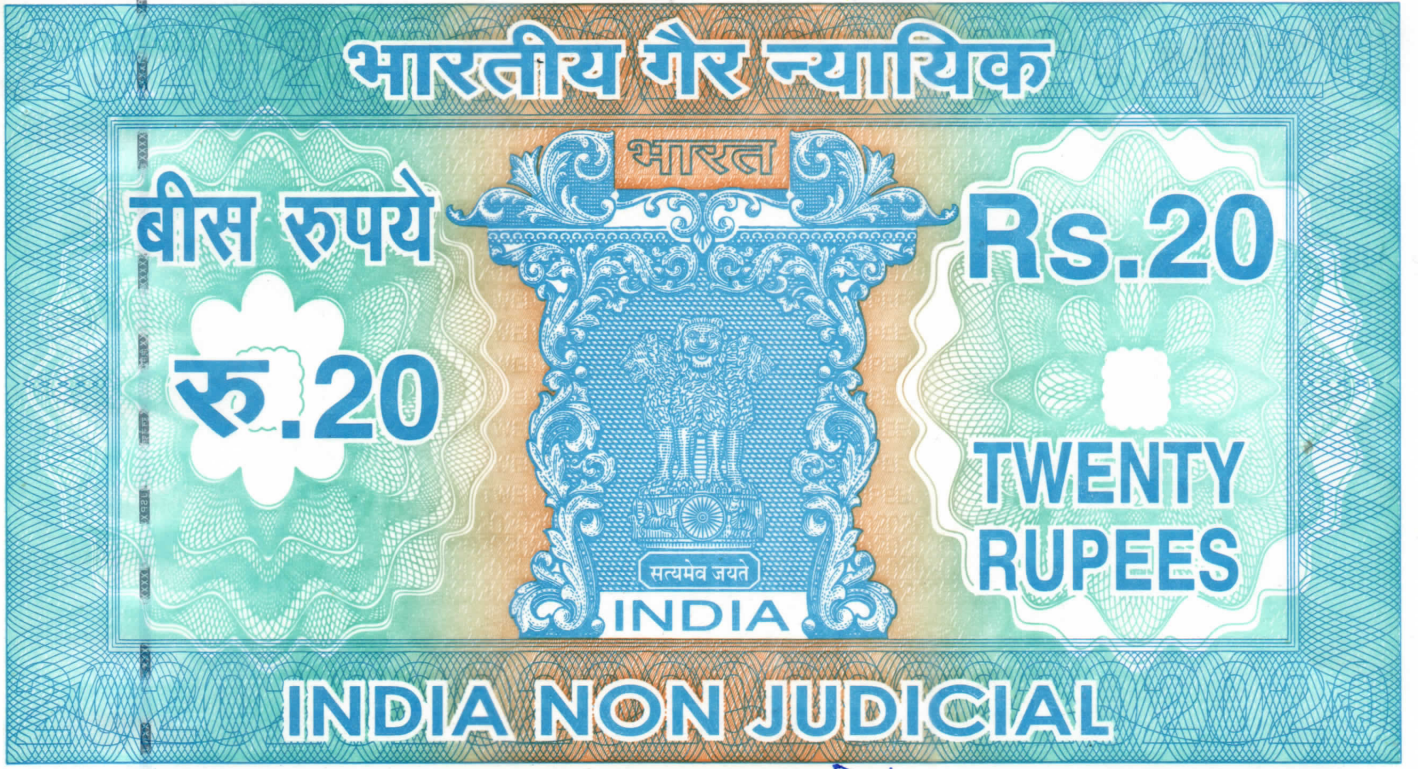

Affidavit cum Declaration of Mr. K.DHANUSHKODI-1, S.MUTHUPANDIAN-2. promoter of the proposed project FRESH LAYOUT in R.S.NO. 12/2B2, 12/3B, SOTTATHATTI Village, THIRUPPUVANAM Taluk, SIVAGANGA.

I K.DHANUSHKODI-1, S.MUTHUPANDIAN-2 promoter of the proposed project do hereby solemnly declare, undertake and state as under:

1. That I / promoter have / has a legal title to the land on which the development of the project is proposed

or

Have enters into joint development agreement/collaboration agreement/development agreement or any other agreement with who possess a legal title to the land on which the development of the proposed project is to carried out

and

A legally valid authentication of title of such land along with an authenticated copy of the agreement between such owner and promoter for development of the project is enclosed herewith.

2. That the said land is free from all encumbrances.

or

Posses such encumbrance's as_ including details of any rights, title, interest or name of nay party in or over such land, along with details.

3. That the time period within which the project is already completed .
4. That seventy per cent of the amounts realised by me/promoter for the real estate project from the allotters, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose, as far as building is concerned. For layout projects, it will be cost of development and the land cost.
5. That the amounts from the separate account, to cover the cost of the project, shall be withdrawn only after due certification by an engineer, architect and a chartered accountant in practice that the withdrawal is in proportion to the percentage of completion of the project, as far as building is concerned. For layout projects, the withdrawal can be done after obtaining a certificate from the Architect/Licensed Surveyor stating that the project has been develop and completed in all respects as per the layout approved by the competent authority.
6. That I / promoter shall get the accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant of the Authority and it shall be verified during the audit that the amounts collected particular project have been utilised for the project and withdrawals have been made in compliance with the proportion to the percentage of completion of the project.
7. That I / promoter shall take all the pending approvals on time, from the competent authorities.
8. That I / promoter have / has furnished such other documents as have been prescribed by the rules and regulations made under the Act.
9. That I / promoter shall not discriminate against any allotter at the time of allotment of any apartment, plot or building, as the case may be, on any grounds.
